

SPONSORSHIP AGREEMENT

This Sponsorship Agreement is made and entered into as of the date of the last signature below 1012 Columbus Rd, Streator, IL, and [Sponsor Name] _____, located at _____

1. Sponsorship Commitment

Sponsor agrees to provide financial support to the Theatre in the amount of \$_____ in exchange for the benefits outlined in the selected sponsorship package. The Sponsor acknowledges and agrees that sponsorship funds are a donation to support the Theatre's mission and programming.

2. Payment Terms

- a) Payment of the Sponsorship Fee shall be made in full within 30 Days from the Effective Date unless otherwise agreed upon in writing by both parties.
- b) In the event of partial payment or non-payment, the Theatre reserves the right to cancel this Agreement without obligation to perform any sponsorship benefits, and any funds already paid shall be retained by the Theatre as liquidated damages.
- c) Payments shall be made via check to the Theatre at the address or banking details provided in a separate invoice or written communication.

3. Term & Termination

- a) This Agreement shall commence on the Effective Date and remain in effect through _____ unless terminated earlier in accordance with this Agreement.
- b) The Theatre reserves the right to terminate this Agreement immediately in the event of:
 - Non-payment or partial payment by the Sponsor;
 - Any action by the Sponsor that is deemed to be in conflict with the mission, values, or reputation of the Theatre;
 - Any breach of the terms outlined in this Agreement.

- c) In the event of termination under this section, the Theatre shall retain all payments made by the Sponsor, and the Sponsor shall have no claim for reimbursement, refund, or damages.

4. Sponsorship Benefits

The Theatre shall provide the Sponsor with the agreed-upon sponsorship benefits as outlined in the selected sponsorship package, subject to compliance with the terms of this Agreement. The

Theatre retains the right to adjust sponsorship benefits as necessary due to unforeseen circumstances or operational considerations.

5. Use of Name, Logo, and Marketing Materials

- a) The Sponsor grants the Theatre a non-exclusive, non-transferable right to use the Sponsor's name, logo, and branding materials in promotional materials related to the sponsorship.
- b) The Sponsor may not use the Theatre's name, logo, or other intellectual property without prior written consent.

6. Limitation of Liability

In no event shall the Theatre be liable for any indirect, incidental, consequential, special, or punitive damages arising out of or related to this Agreement, even if advised of the possibility of such damages. The Theatre's total liability under this Agreement shall not exceed the amount of the Sponsorship Fee received from the Sponsor.

7. Force Majeure

Neither party shall be liable for any delay or failure in performance due to acts of God, natural disasters, governmental actions, pandemics, or other circumstances beyond its reasonable control.

8. Governing Law & Dispute Resolution

This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois. Any disputes arising under this Agreement shall first be resolved through good faith negotiations. If the dispute remains unresolved, the parties agree to submit to the jurisdiction of the courts of Illinois.

9. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, whether written or oral, relating to the subject matter herein. Any modifications must be made in writing and signed by both parties.
